June 1, 2017 – May 31, 2018 HOMMOCKS POOL MEMBERSHIP CLASSIFICATIONS

Family: An individual card will be issued for each member of the immediate family who permanently resides in the home (parent(s) & children under 23 years of age).

No further charge incurred once permit has been issued.

Individual: No further charge incurred once permit has been issued.

Senior Citizen: Eligibility is age 62 & older. Senior citizen card or proof of age must be shown at time of registration. No further charge incurred once permit has been issued.

Basic Individual: An adult (13 years & older), having this type of card will be charged \$3 each time the card is used. A child (12 years & under) having this type of card will be charged \$2 each time the card is used. No guest privileges are included with this permit.

Rye Neck: Includes ONLY those residing in the Village of Mamaroneck, but not the Town of Mamaroneck (Rye Neck section).

Non Resident: Permits will be issued to those families & individuals who reside outside the Town of Mamaroneck & Rye Neck.

Caregiver: Offered to households with a valid pool permit only. Sponsoring family must appear with caregiver at time of registration.

Guest Fees: During the summer, permit holders are entitled to bring one guest per card holder. During the school year, permit holders may bring up to four guests per card holder.

No guest privileges allowed with Basic permits. Permit holders must accompany their guests in the pool area. All guests will be required to pay the prevailing guest fee.

Adult Guest (13 years & older) \$6 Weekdays/\$12 Weekends & Holidays **Child Guest (12 years & under)** \$3 Weekdays/\$6 Weekends & Holidays

Guest Card \$95 Must have a valid pool permit to purchase. Not valid w/ Basic Permit. Guest cards may only be used when presented by a valid Pool Permit holder.

HOMMOCKS POOL RULES AND REGULATIONS

The following Rules and Regulations are in place for your safety and enjoyment during your stay. We ask that you please review and follow them so that all patrons can enjoy their visit.

1. Please be aware of pool depth markers.
2. Please obey lifeguards: No talking to the lifeguards unless requesting emergency assistance.
3. Street clothing is not permitted in the pool area. Exception to this would be for special events such as swim meets, lessons, etc.
4. Smoking is not permitted in the pool complex, locker rooms or hallways.
5. No alcoholic beverages permitted.
6. No running, ball playing or dangerous play is allowed anywhere in the pool complex.
7. Diving boards are not open to the public.
8. Adults are responsible for and must supervise any child using a swim aid (bubbles/water rings). Adults must be in the water with their child within arm's reach at all times.
9. Children 12 and under sent to the pool without adequate supervision will not be allowed admittance.
10. Town flotation equipment is not available for use by the public. Swim aids (face masks, snorkel, etc.) are not permitted in the pool without approval of the Pool Director.
11. Babies still in the "diaper stage" are permitted in the pool with rubber pants covering diaper or by wearing a swim diaper. No exceptions.
12. Baby carriages & chairs are not permitted on the main pool deck or within 5 feet of the training pool edge.
13. No radios or tape players are permitted in the pool or patio area. Radios may be used with headphones only.
14. Proper swimming attire required – no cutoffs permitted.
15. The Town of Mamaroneck is not responsible for any lost or stolen items from the pool (lock-up!). You must provide your own lock. Lockers available free of charge.
16. Chairs & tables may not be reserved for an entire day. Adults have priority over children using lawn furniture.
17. Pools will close upon first clap of thunder or sighting of lightning & will remain closed until management deems it safe to re-open. All patrons MUST go indoors. No refunds due to inclement weather conditions.
18. Please use gender specific locker rooms with children over 6 years old.
19. Entrance to all facilities is through the locker rooms. No one will be admitted through the outside gates or pool deck.

KEEP IT CLEAN

Please help us keep the pool facility clean and safe by following a few simple guidelines:

1. Dispose of trash/recyclables in the proper receptacle.
2. No glass containers allowed in the pool facility.
3. Please keep all food and drink items off the concrete decks. No food or drinks permitted in the pool area.

NOTES

1. The circle lap swimming program in designated lanes will be implemented at the discretion of the Manager on Duty (3 adults may swim in each lane).
2. Management reserves the right to close certain sections and/or pools to ensure swimmer safety and meet health code requirements.
3. Everyone MUST have a valid pool permit OR be a guest of a permit holder and pay prevailing guest fee to enter pool complex.
4. We encourage all parents of young children to please remember to be cognizant of bathroom breaks.

COOLER POLICY

The Town has a contractual agreement with Slapshot Café for the pool concession. Therefore, outside food including food deliveries is prohibited within the pool complex during the summer. Persons will be permitted to bring a **small personal size** handheld cooler into the facility. Any cooler larger than personal size **will not** be permitted. For your convenience the Concession Stand is open daily from 12:00 pm – 6:30 pm. Management reserves the right to deny any coolers it deems larger than personal sized. For further information regarding this policy or cooler size restrictions, please speak to the Pool Manager on Duty.

STORM/EVACUATION PROCEDURES

During the summer season there is always the possibility of severe weather. When a storm approaches it is extremely important to take immediate action for the safety of our patrons and staff. Below details the emergency evacuation procedure at our pools:

1. At the sound of the first thunderclap, staff will blow their whistle and an announcement will be made for all patrons to evacuate the pools and seek shelter in the hallway.
2. Showering will not be permitted during this time.
3. Patrons will not be allowed back into the water until 30 minutes after the last sound of thunder is heard or sign of lightning.

PARENTAL RESPONSIBILITY

Parents are responsible for the supervision of their children within the pool complex. Actions of improperly supervised children put children at risk and can distract the lifeguards from their primary responsibilities. Pool rules state that children 12 and under must be accompanied by an adult. Adults are responsible for and must supervise any child using a swim aid (bubbles/water rings). Adults must be in the water with their child within arm's reach at all times. Although children 13 and over are permitted to attend unaccompanied, parents are still responsible for seeing that the child knows and abides by the pool rules and regulations.
